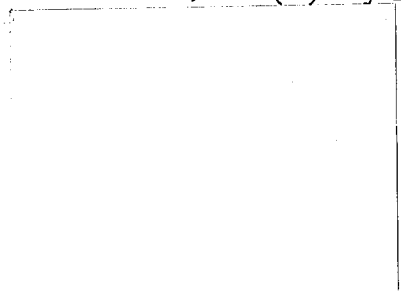

**ORDER REGARDING THE 2017
ANNUAL FIDUCIARY ACCOUNTING WITH RESPECT TO
THE PERRINE-DUPONT MEDICAL MONITORING
QUALIFIED SETTLEMENT FUND**

On the 27th day of November, 2018, Edgar C. Gentle, III, the Claims Administrator previously appointed by the Court for the Perrine-DuPont Medical Monitoring Qualified Settlement Fund (the "Medical Fund"), submitted the proposed 2017 Annual Fiduciary Accounting for the Medical Fund and Application for an Order approving the Accounting with respect to the Medical Fund (the "2017 Accounting") to the Court, the Guardian Ad Litem and the Finance Committee.

The Court takes judicial notice of the fact that no inquiries or objections concerning the 2017 Accounting have been lodged. Accordingly, the Court ORDERS, ADJUDGES and DECREES that (i) the 2017 Accounting for the Medical Fund is hereby approved, (ii) the Claims Administrator is hereby released and discharged from any further liability or responsibility as to all matters disclosed in the 2017 Accounting for the Medical Fund, and (iii) any future action against the Claims



Administrator for breach of trust or fiduciary duty arising out of any matter disclosed in the 2017 Accounting for the Medical Fund is barred.






