

PROPOSED 2011 ANNUAL FIDUCIARY ACCOUNTING FOR THE
PERRINE-DUPONT PROPERTY REMEDIATION QUALIFIED SETTLEMENT FUND
AND APPLICATION FOR AN
ORDER APPROVING THE ACCOUNTING

TO THE HONORABLE THOMAS A. BEDELL,
CIRCUIT JUDGE OF HARRISON COUNTY, WEST VIRGINIA, IN CAMERA:

COMES NOW, Edgar C. Gentle, III, the Claims Administrator of the Perrine-DuPont Property Remediation Qualified Settlement Fund (the "Fund"), and, pursuant to the terms of the November 19, 2010 Memorandum of Understanding, which led to the establishment of the Remediation Fund, entered into by Settling Plaintiffs' Counsel and Settling Defendants' Counsel, hereby (i) submits the following proposed 2011 Annual Fiduciary Accounting for the Remediation Fund, and (ii) requests an Order approving the 2011 Annual Fiduciary Accounting for the Remediation Fund and granting a judicial settlement of account. In support thereof, the Claims Administrator respectfully submits the following report of his acts and doings in such fiduciary capacity for the Remediation Fund for the year ended December 31, 2011.


Please find enclosed the Remediation Fund's 2011 Financial Statement. The Financial Statement consists of (i) a Balance Sheet of the Remediation Fund at December 31, 2011 in Schedule I; and (ii) a Schedule of Receipts Collected, Expenses Paid and Changes in Fund Balance of the Remediation Fund for the year ended December 31, 2011 (the "Year") in Schedule II. Additionally, the Claims Administrator Disbursement Ledger for the Year is also provided for the Remediation Fund's checking and money market accounts.

As the Schedule of Receipts Collected, Expenses Paid and Changes in Fund Balance of the Remediation Fund indicates, on an accrual basis Remediation Fund expenditures totaled \$32,013,609 during the Year, of which: (a) \$30,481,236 was attributable to Class Representative Incentive Awards and Class Counsel Attorney Fees and Expenses, and (b) \$1,532,373 was attributable to expenses associated with the administration of the Remediation Fund. Therefore, during the Year, 95.21% of Remediation Fund expenditures were attributable to Class Representative Incentive Awards and Class Counsel Attorney Fees and Expenses, and 4.79% of Remediation Fund expenditures were attributable to expenses associated with the administration of the Remediation Fund.

Also, during the Year, the Remediation Fund's investment and other interest bearing accounts generated a net gain of \$13,917 on an accrual basis of accounting, for a total annualized yield of **approximately 0.03%**.

WHEREFORE, premises considered, the Claims Administrator respectfully requests entry of an Order judicially settling and approving his 2011 Annual Fiduciary Accounting for the Remediation Fund and thereby discharging the Claims Administrator from any and all liability as to any matter disclosed in the 2011 Annual Fiduciary Accounting.


