## ORDER APPROVING THE PAYMENT OF THE MAY 2011 STATEMENT OF THE CLAIMS ADMINISTRATOR

On June 3, 2011, Edgar C. Gentle, III, the Claims Administrator previously appointed by the Court for the Settlement Funds established herein, submitted a proposed statement for services rendered and expenses incurred from May 1, 2011 to May 31, 2011 to the Court and the Finance Committee.

The Court takes judicial notice of the fact that the statement is within the initial settlement budget approved by the Court and no inquiries or objections concerning the proposed statement have been lodged by the Finance Committee. Upon reviewing the proposed statement, the Court finds it to be fair and reasonable and hereby approves it. Accordingly, the Court hereby authorizes and directs the Claims Administrator and MVB Bank, Inc., the Custodian of the Settlement Funds, to disburse to Edgar C. Gentle, III the amount of \$116,448.49, constituting payment of his statement for May 2011, with: (1) \$55,974.25 to be paid from the Perrine-DuPont Property Remediation
