ORDER APPROVING THE WINDING UP OF THE PERRINE DUPONT
PROPERTY REMEDIATION QUALIFIED SETTLEMENT FUND

On December 29, 2017, the Claims Administrator submitted to the Court a Report requesting authority to: (i) transfer the balance of the Perrine DuPont Property Remediation Qualified Settlement Fund (the "Remediation Fund") to a Remediation Fund Sinking Fund to be held as a subaccount of The Perrine DuPont Medical Monitoring Qualified Settlement Fund (the "Medical Monitoring Fund"), less the \$66,978.08 amount for the 58 checks drawn on the Remediation Fund that are still outstanding; and (ii) terminate the Remediation Fund at the time all such checks are either cashed or have become stale, which would be February 28, 2018.

The Claims Administrator reported the following to the Court, and made the following recommendations:

(1) At this time, the Remediation Fund has approximately \$335,000 remaining on an accrual basis. The Claims Administrator recommends the transfer of these monies to the Remediation Fund

Sinking Fund, less the retention of \$66,978.08 to be held in the Remediation Fund checking account to cover current outstanding checks. Remediation Fund claimants have 90 days within which to cash checks issued by the Remediation Fund. The Claims Administrator further recommends that the Remediation Fund checking account be closed and the remaining Remediation Fund checking account balance transferred to the Remediation Fund Sinking Fund after February 6, 2018, representing 90 days from the last issued claimant check of November 6, 2017; and

(2) The Court terminate the Remediation Fund at February 28, 2018.

After reviewing the Report, and taking into account all other matters and things as it deems appropriate, it is hereby ORDERED, ADJUDGED and DECREED as follows:

1. The December 29, 2017 Report of the Claims Administrator regarding the winding up of the Remediation Fund by transferring the remaining balance of the Remediation Fund (excepting the amount of outstanding checks drawn on the Remediation Fund's checking account) to the Remediation Fund Sinking Fund is hereby approved;
2. The Settlement Fund shall hereby be terminated at February 28, 2018; and
3. Provided that the Claims Administrator, his agents, employees, co-workers or staff act in accordance with the provisions of this Order, they are hereby granted judicial immunity.






