**ORDER PROVIDING THE SETTLEMENT ADMINISTRATOR AUTHORITY TO  
CLOSE THE REMEDIATION OF ZONE 1B AND ZONE 2 PROPERTIES**

Presently before the Court is the Claims Administrator's July 28, 2014 Report requesting Court authority to conclude the remediation of Zones 1B and 2 properties.

The Claims Administrator reports that, of the 395 houses originally signed up for the Program in Zones 1B and 2: (i) 81 house properties tested clean and did not require remediation; (ii) 186 have been remediated by NCM; (iii) 123 have Claimants who requested to opt-out of the Settlement or who filed claims that were denied; and (iv) 5 listed in an In Camera Exhibit submitted to the Court which have already been released to NCM but are not complete at this time due to the issues noted in the Exhibit.

After a careful review of the Claims Administrator's Report, the Court hereby determines that the Settlement remediation of Zones 1B and 2 are complete except for the 5 properties listed in an In Camera Exhibit filed with the Court. Accordingly, with the exception of the above 5 properties, the Settlement Remediation Program with respect to Zones 1B and 2 is hereby completed.

Provided that the Claims Administrator acts in accordance with the terms of this Order, he, and his staff, employees and agents are granted Judicial Immunity.






