ORDER REGARDING THE 2015
ANNUAL FIDUCIARY ACCOUNTING WITH RESPECT TO
THE PERRINE-DUPONT PROPERTY REMEDIATION
QUALIFIED SETTLEMENT FUND

On the 6th day of September, 2016, Edgar C. Gentle, III, the Claims Administrator previously appointed by the Court for the Perrine-DuPont Property Remediation Qualified Settlement Fund (the "Remediation Fund"), submitted the proposed 2015 Annual Fiduciary Accounting for the Remediation Fund and Application for an Order approving the Accounting with respect to the Remediation Fund (the "2015 Accounting") to the Court, the Guardian Ad Litem and the Finance Committee.

The Court takes judicial notice of the fact that no inquiries or objections concerning the 2015 Accounting have been lodged. Accordingly, the Court ORDERS, ADJUDGES and DECREES that (i) the 2015 Accounting for the Remediation Fund is hereby approved, (ii) the Claims Administrator is hereby released and discharged from any further liability or responsibility as to all matters

disclosed in the 2015 Accounting for the Remediation Fund, and (iii) any future action against the Claims Administrator for breach of trust or fiduciary duty arising out of any matter disclosed in the 2015 Accounting for the Remediation Fund is barred.
